NEW BUSINESS

- 1. Discuss and consider approval of the Preliminary Plat of Lots 1-3, Block 1, Sansom Heights Addition, being 28.979 acres of land situated in the J. Bowman Survey, Abstract No. 81; the A. Van Nordstand Survey, Abstract No. 63, City of Sansom Park, Tarrant County, Texas and generally located on the south side of Azle Ave., east of La Junta. Mayor Barnett Jr., advises Council that this is the Preliminary plat for said property and the developer will be bringing a final plat to Council in the near future. The City Engineer along with the City Planner has approved this preliminary plat and requests Council consideration.
- Member Barnett, Sr. makes a motion to approve the Preliminary plat, second by Mayor ProTem Harris. Council voted unanimously to approve the Preliminary Plat of Lots 1-3, Block 1, Sansom Heights Addition, being 28.979 acres of land situated in the J. Bowman Survey, Abstract No. 81; the A. Van Nordstand Survey, Abstract No. 63, City of Sansom Park, Tarrant County, Texas and generally located on the south side of Azle Ave., east of La Junta. Motion carried 4-0.
- 2. Discuss and consider approval of a Service Agreement between the City of Sansom Park and iWorkQ Systems for a Community Development package for Permitting department and Code Enforcement. City Administrator Greg Hutson stated additionally that the software will not only enhance both departments with more capabilities, but will also allow them access while they are out in field.

Council voted unanimously to approve the Service Agreement between the City of Sansom Park and iWorkQ Systems for a Community Development package for Permitting department and Code Enforcement. Motion carried 4-0.
